**REVOCATION ORDER**

On this day, the matter of John William Pribil (“Respondent”) comes before Jay Bradford, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Ava Franks, Associate Counsel, in this matter.

**FINDINGS OF FACT**

1. Respondent holds Arkansas Nonresident Producer License No. 340706.
2. On or about September 16, 2013, the Kansas Insurance Department revoked Respondent’s nonresident license by way of Summary Order.
3. Respondent did not disclose the aforementioned matter to the Department within thirty (30) days.

**CONCLUSIONS OF LAW**


From the Findings of Fact contained herein, the Commissioner concludes as follows:

4. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. §23-61-103.
5. Respondent failed to disclose administrative action to the Department within thirty (30) days as required by Arkansas Code §23-64-517(b)(1).

**RECOMMENDATION OF THE HEARING OFFICER**

WHEREFORE, based upon the foregoing Findings of Fact, Conclusions of Law, and other matters before him, the Hearing Officer recommends:

7. Respondent's Arkansas Nonresident Producer License No. 340706 should be revoked.


