ARKANSAS MULTI-AGENCY VEHICLE INSURANCE PROGRAM

(2012-2013 Coverage Highlights)

General Policy Information

- Liability coverage for named insureds **ONLY** on all owned or leased "autos".
- Excess liability coverage for the use of a personal vehicle by an employee of a named insured while on **Official Business Only**.
- Liability coverage: Combined single limit for Bodily Injury and Property Damage
 - Option I: \$250,000 In-State / \$2,000,000 Out-of-State
 - Option II: \$500,000 In-State / \$2,000,000 Out-of-State
 - Option III: \$1,000,000 In-State / \$2,000,000 Out-of-State
- Uninsured and Underinsured Motorist Bodily Injury Coverage - \$250,000.
- Uninsured and Underinsured Motorist Physical Damage Coverage – Not Provided.
- Physical Damage Coverage applies only to those vehicles with premium indicated on the schedule.
- Medical Payments - \$5,000 Medical Payment coverage per passenger.
- Recommend for all out-of-state travel, the use of public transportation as opposed to owned, hired, or employee owned "autos".

Deductibles for Physical Damage (*Comprehensive and Collision*)

- Comprehensive - \$500 per vehicle per occurrence.
- Collision - \$1,000 per vehicle per occurrence.

Rental Vehicles: (less than 30 days)

- Contact DFA Office of State Procurement for information – State Rental Vehicle Contract.
- Automatic Liability Coverage for official business only.
- Comprehensive and Collision Damage coverage is available - \$25/day per vehicle. \$50,000 maximum limit of Insurance.
- Recommend the purchase of Liability and Comprehensive and Collision damage coverage from the vendor for rented vehicles used for all in state or out of state travel.
- Excess Liability Coverage when the rental vehicle is in the name of the individual but for **OFFICIAL BUSINESS USE ONLY**.

Leased Vehicles: (30 days or more)

- Liability and physical damage coverage must be listed on vehicle schedule.

Mobile Equipment

- Liability coverage will only apply to specifically scheduled mobile equipment.
- Liability coverage does not apply to "Bodily Injury" or "Property Damage" resulting from the operation of any machinery that is on, attached to, or part of any of this mobile equipment.

Trailers

- Trailers with a load capacity of more than 2,000 lbs. must be scheduled for liability and/or physical damage coverage.
- Liability Coverage for a trailer with a load capacity of 2,000 lbs. or less is provided by the towing vehicle.
- Physical Damage Coverage is available on trailers with a 2,000 lb. or less load capacity.

Changes or Deletions

- Request to Add Vehicles form must be completed and submitted to Risk Management to add coverage for any newly-purchased or leased vehicles. See forms at www.insurance.arkansas.gov.
- Changes and deletions must be submitted on Vehicle Schedule. To request a change or deletion, circle VIN number, make change or write "Delete", sign, date and fax revised vehicle schedule to Risk Management at (501) 371-2842.
