EMERGENCY SUSPENSION ORDER

---

On this day, the matter of Bryan Johnson (“Respondent”) and Iplan Health Group, LLC., came before Allen Kerr, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Gray Allen Turner, Associate Counsel, in this matter. From the facts and law before him, the Commissioner finds as follows:

FINDINGS OF FACT

1. Respondent Johnson holds an Arkansas Non-Resident Producer License, National Producer Number 17146224. Respondent resides in Boca Raton, FL.
2. Respondent Iplan Health Group holds an Arkansas Non-Resident Producer License, National Producer Number 17184861. Iplan Health Group is located in Boca Raton, Florida, and is owned and operated by Respondent Bryan Johnson.

3. The Respondents, while acting as producers, have utilized unlicensed staff members to transact health insurance with customers in Arkansas. The non-licensed staff members were soliciting insurance policies and received commissions for their sales.

### CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

1. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. § 23-61-103.

2. The Commissioner has the authority to issue an emergency license suspension pursuant to Ark. Code Ann. §§ 23-64-216(e) and 25-15-211(c).

3. An administrative hearing will be held promptly, as required by Ark. Code Ann. § 23-64-216(e)(2). A Notice of Hearing is being served herewith.

4. The Commissioner and the Department reserve the right to amend the allegations, findings and conclusions set forth herein and further reserve the right to present additional allegations and evidence in any subsequent order or administrative hearing.

#### IT IS THEREFORE ORDERED:

In consideration of the Commissioner's Findings of Fact and Conclusions of Law, the Respondent's Arkansas Resident Producer Licenses, of Bryan Johnson, National Producer Number 17146224, and Iplan Health Group, National Producer Number 17184861 are hereby immediately suspended.
