REVOCATION ORDER

---

On this day, the matter of the insurance producer’s license of Timothy Davis (“Respondent”) came before Alan McClain, Arkansas Insurance Commissioner (“Commissioner”). A hearing was held on December 19, 2022, in the Second Floor Hearing Room of the Arkansas Insurance Department (“Department”) pursuant to the Notice of Hearing dated December 6, 2022. The hearing was held before Russ Galbraith, Chief Deputy Insurance Commissioner and Hearing Officer (“Hearing Officer”) pursuant to his appointment by the Commissioner in accordance with Ark. Code Ann. § 23-61-103(e)(1). The Department was represented by Gray Allen Turner, Associate Counsel. The Respondent did not appear.

FINDINGS OF FACT

1. Respondent holds an Arkansas resident insurance producer license, NPN 18000332.

2. Respondent is a resident of Pulaski County, Arkansas.
3. A notice of hearing was sent on December 6, 2022, to the last address Respondent provided to the Department by both regular and certified mail and notice has been sent as required by statute.
4. The Department received notice from the Office of Child Support Enforcement on November 2, 2022, that Respondent was three or more months in arrears on his court ordered child support, had not made appropriate payment arrangements, and that the license issued to the Respondent “must be suspended.”
5. Respondent failed to appear to at the hearing.

#### CONCLUSIONS OF LAW

1. The Commissioner of Insurance has jurisdiction pursuant to the Arkansas Insurance Code, specifically Ark. Code Ann. §§ 23-60-101, et seq.
2. Under the provisions of Ark. Code Ann. § 23-64-512(a)(14), the failure to comply with an order imposing a child support obligation is grounds for suspension or revocation of a producer’s license. Respondent’s actions are a violation of Ark. Code Ann. § 23-64-512(a)(14).

**RECOMMENDATION OF HEARING OFFICER**

WHEREFORE, upon consideration of the evidence of record and the foregoing Findings of Fact and Conclusions of Law, the Hearing officer recommends the following:

1. That the Arkansas resident insurance producer license of the Respondent be revoked.
2. That following the expiration of three (3) years from the date of this order, the Respondent may apply to reinstate his license in accordance with the provisions of Ark. Code Ann. § 23-64-217(b).
