## REVOCATION ORDER

On this day, the matter of the insurance producer's license of Andrea Ceballos ("Respondent") came before Alan McClain, Arkansas Insurance Commissioner ("Commissioner"). A hearing was held on March 9, 2022, in the Second Floor Hearing Room of the Arkansas Insurance Department ("Department") pursuant to the Notice of Hearing dated February 28, 2022. The hearing was held before Russ Galbraith, Chief Deputy Insurance Commissioner and Hearing Officer ("Hearing Officer") pursuant to his appointment by the Commissioner in accordance with Ark. Code Ann. § 23-61-103(e)(1). The Department was represented by Gray Allen Turner, Associate Counsel. The Respondent did not appear.

#### FINDINGS OF FACT

Respondent holds an Arkansas resident insurance producer license,
NPN 16821238.

- 2. Respondent is a resident of Union County, Arkansas.
- 3. A notice of hearing was sent on February 28, 2022, to the last addresses Respondent provided to the Department, including her mailing address and home address. These notices were sent by both regular and certified mail and notice has been sent as required by statute.
- 4. Respondent was charged with felony theft of property in Union County Circuit Court case 70CR-2021-277-1 on May 18, 2021. Respondent failed to inform the Department of her criminal charges within thirty days of the filing of the charge.
- 5. Respondent failed to appear to court as to her criminal charges and was issued a warrant for failure to appear.

### CONCLUSIONS OF LAW

- 1. The Commissioner of Insurance has jurisdiction pursuant to the Arkansas Insurance Code, specifically Ark. Code Ann. §§ 23-60-101, et seq.
- 2. Respondent failed to disclose to the Department the filing of a criminal charge against her within thirty days. Respondent's actions as described were a violation of Ark. Code Ann. §§ 23-64-201 and 23-64-517.

## RECOMMENDATION OF HEARING OFFICER

WHEREFORE, upon consideration of the evidence of record and the foregoing Findings of Fact and Conclusions of Law, the Hearing officer recommends the following:

- 1. That the Arkansas resident insurance producer license of the Respondent be revoked.
- 2. That following the expiration of three (3) years from the date of this order, the Respondent may apply to reinstate her license in accordance with the provisions of Ark. Code Ann. § 23-64-217(b).
