REVOCATION ORDER

On this day, the matter of the insurance producer's license of Ms. Paige Harbour, "Respondent") came before Alan McClain, Arkansas Insurance Commissioner ("Commissioner"). A hearing was held on March 27, 2023, in the Second Floor Hearing Room of the Arkansas Insurance Department ("Department") pursuant to the Notice of Hearing dated February 24, 2023. The hearing was held before Russ Galbraith, Chief Deputy Insurance Commissioner, ("Hearing Officer") pursuant to his appointment by the Commissioner in accordance with Ark. Code Ann. § 23-61-103(e)(1). The Department was represented by Gray Allen Turner, Associate Counsel. The Respondent was not present.

FINDINGS OF FACT

1. Respondent is a resident of Van Buren, Arkansas.
2. Respondent holds an Arkansas resident insurance producer license.
3. The Notice of Hearing was sent to Respondent's last known address on February 24, 2023, and notice requirements have been met.
4. After receiving a complaint alleging Respondent had engaged in fraudulent activity, the Department sent written inquiries to Respondent's last known address on December 8, 2022. Respondent failed to respond to written inquiries from the Department within 30 days.
5. Respondent has had no communication with the Department and

did not participate in the hearing.

CONCLUSIONS OF LAW

1. The Commissioner of Insurance has jurisdiction pursuant to the Arkansas Insurance Code, specifically Ark. Code Ann. §§ 23-60-101 *et seq.*


2. It is a violation of Ark. Code Ann. § 23-64-512(a)(13) to fail to respond to a written inquiry from the Department within 30 days.

Respondent's actions as described above were a violation of § 23-64-512(a)(13).

RECOMMENDATION OF HEARING OFFICER

WHEREFORE, upon consideration of the evidence of record and the foregoing Findings of Fact and Conclusions of Law, the Hearing officer recommends the following:

That the Arkansas resident insurance producer license of Respondent Paige Harbour be revoked.
