REVOCAATION ORDER

On this day, the matter of Allan Sages (“Respondent”) comes before Jay Bradford, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Ava Franks, Associate Counsel, in this matter.

FINDINGS OF FACT

1. Respondent holds Arkansas Nonresident Producer License No. 418765.
2. On or about November 23, 1987, Respondent pled guilty to the crime of lewdness.
3. On or about November 20, 2013, the Department mailed a written inquiry to Respondent regarding this termination.
4. Respondent did not disclose this criminal conviction on his application.
5. On or about January 7, 2014 the Department mailed a written inquiry as to this matter.
6. Respondent did not respond to the Department’s written inquiry within thirty (30) days.

CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

7. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Arkansas Code §23-61-103.

8. Respondent provided materially untrue information on his license application, which is a ground for licensure revocation. Ark. Code Ann. §23-64-512(a)(1).

9. Respondent failed to provide a written response to the Department's written inquiry within thirty (30) days as required by Arkansas Code §23-64-512(a)(13).

RECOMMENDATION OF THE HEARING OFFICER

WHEREFORE, based upon the foregoing Findings of Fact, Conclusions of Law, and other matters before him, the Hearing Officer recommends:

10. Respondent's Arkansas Nonresident Producer License No. 418765 should be revoked.




