REVOCATION ORDER

On this day, the matter of Rampersaud Narain (“Respondent”) comes before Jay Bradford, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Ava Franks, Associate Counsel, in this matter.

FINDINGS OF FACT

1. Respondent holds Arkansas Nonresident Producer License No. 387555.
2. On or about June 17, 2013, the West Virginia Insurance Department revoked Respondent’s Non-Resident Insurance License.
3. Respondent did not disclose the aforementioned matter to the Department within thirty (30) days.
4. On or about September 18, 2013, the Department mailed a written inquiry to Respondent regarding this administrative action.
5. Respondent did not respond to the Department’s inquiry within thirty (30) days.

CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

6. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. §23-61-103.

7. Respondent failed to disclose the administrative action to the Department within thirty (30) days as required by Arkansas Code §23-64-517(b)(1).

8. Respondent failed to provide a written response to the Department's written inquiry within thirty (30) days as required by Arkansas Code §23-64-512(a)(13).

RECOMMENDATION OF THE HEARING OFFICER

WHEREFORE, based upon the foregoing Findings of Fact, Conclusions of Law, and other matters before him, the Hearing Officer recommends:

9. Respondent's Arkansas Nonresident Producer License No. 387555 should be revoked.
