**REVOCATION ORDER**

---

On this day, the matter of Philip Connealy (“Respondent”) comes before Jay Bradford, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Ava Franks, Associate Counsel, in this matter.

**FINDINGS OF FACT**

1. Respondent holds Arkansas Nonresident Producer License No. 363127.
2. On or December 16, 2013, the South Dakota Department of Labor and Regulation Division of Insurance revoked Respondent’s Nonresident Producer License for failure to report an administrative action taken against his license by the state of Florida.
3. Respondent did not disclose the aforementioned matter to the Department within thirty (30) days.
4. The Department mailed a written inquiry to the Respondent’s address on record regarding this matter on or about April 28, 2014.
5. Respondent did not respond to the written inquiry.
6. A hearing was scheduled and held June 10, 2014.
7. Respondent did not appear at the hearing.

### CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

8. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. §23-61-103.

9. Respondent failed to disclose the administrative action taken on his license to the Department within thirty (30) days as required by Arkansas Code §23-64-517(b)(1).

10. The Commissioner may revoke a producer's license for failure to cooperate with the Commissioner in an investigation when required by the Commissioner. Ark. Code Ann. §23-64-512(a)(17).

### RECOMMENDATION OF THE HEARING OFFICER

WHEREFORE, based upon the foregoing Findings of Fact, Conclusions of Law, and other matters before him, the Hearing Officer recommends:

9. Respondent's Arkansas Nonresident Producer License No. 363127 should be revoked.
