REVOCATION ORDER

On this day, the matter of Nyaten Gaye (“Respondent”) comes before Allen Kerr, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Gray Allen Turner, Associate Counsel, in this matter.

FINDINGS OF FACT

1. Respondent holds Arkansas Nonresident Producer License No. 16555755.
2. On or about May 9, 2003, the respondent was convicted of theft by unauthorized taking or transfer in Biddeford, Maine.
3. Respondent stated she had never been convicted of a crime on her National Association of Insurance Commissioners Uniform Application.
4. Respondent's Iowa non-resident producer license was revoked with monetary penalty on June 1, 2014, for failure to respond.

5. Respondent's North Dakota non-resident producer was revoked on July 11, 2014, for failure to respond.

6. Respondent's Georgia non-resident producer license was suspended July 1, 2014, for failure to respond.

7. The Respondent did not inform the Petitioner that her licenses had been revoked within thirty days.

CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

8. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. § 23-61-103.

9. Respondent failed to inform the Arkansas Insurance Department that her licenses had been revoked within thirty days.

10. Respondent failed to disclose a criminal conviction for theft on her National Association of Insurance Commissioners Uniform Application.

RECOMMENDATION OF THE HEARING OFFICER

WHEREFORE, based upon the foregoing Findings of Fact, Conclusions of Law, and other matters before him, the Hearing Officer recommends:

11. Respondent's Arkansas Nonresident Producer License, NPR No. 16555755 should be revoked.
