REVOCATION ORDER

On this day, the matter of the producers' licenses of Bryan Johnson ("Respondent") and Iplan Health Group, LLC., came before Allen Kerr, Arkansas Insurance Commissioner ("Commissioner"). A hearing was held on January 14, 2016, in the First Floor Hearing Room of the Arkansas Insurance Department ("Department") pursuant to the Notice of Hearing dated November 23, 2015. The hearing was held before Chief Deputy Commissioner Russ Galbraith ("Hearing Officer") pursuant to his appointment by the Commissioner in accordance with Ark. Code Ann. § 23-61-103(e)(1). The Department was represented by Gray Allen Turner, Associate Counsel. The Respondents were not present.

FINDINGS OF FACT

1. The Commissioner of Insurance has jurisdiction pursuant to the Arkansas Insurance Code, specifically Ark. Code Ann. §§ 23-60-101, *et seq.*
2. Respondents were sent a notice of hearing on November 23, 2015, by certified and first-class mail.
3. Respondents reside in Florida.

4. The Respondents, Mr. Johnson and the Iplan Health Group insurance agency, while acting as Arkansas non-resident producers, utilized unlicensed staff members to transact health insurance with customers in Arkansas. The staff members were soliciting insurance policies and received commissions for their sales.

CONCLUSIONS OF LAW

1. Ark. Code Ann. § 23-64-512(a)(12) prevents insurance producers from knowingly accepting insurance business from an individual who is not licensed. Respondents' use of unlicensed agents is therefore a violation of Ark Code Ann. § 23-64-512(a)(12).

RECOMMENDATION OF HEARING OFFICER

WHEREFORE, upon consideration of the evidence of record and the foregoing Findings of Fact and Conclusions of Law, the Hearing officer recommends the following:

1. That the Arkansas Insurance Non-Resident Producer's licenses of Respondents Bryan Johnson and the IPlan Health Group be revoked
