REVOCATION ORDER

On this day, the matter of Herman Vaughn, (“Respondent”) comes before Allen Kerr, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Gray Allen Turner, Associate Counsel, in this matter.

FINDINGS OF FACT

1. Respondent holds Arkansas Resident License, National Producer Number 17830507.
2. On or about December 22, 2016, the Petitioner received notice from the Office of Child Support Enforcement that the Respondent was three or more months in arrears on child support payments. (Exhibit 4)
3. An emergency suspension order was issued suspending Respondent's insurance producer license on January 4, 2017. (Exhibit 3)
4. Notice of Hearing was sent to Respondent's last known address by regular and certified mail in a timely manner. (Exhibit 2).

5. Respondent did not appear at the February 27, 2017, administrative hearing.

CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:


6. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. § 23-61-103.

7. Respondent is three or more months in arrears as to his child support obligations, a violation of Ark. Code Ann. § 23-64-512(a)(14).

RECOMMENDATION OF THE HEARING OFFICER

WHEREFORE, based upon the foregoing Findings of Fact, Conclusions of Law, and other matters before him, the Hearing Officer recommends:

7. Respondent's Arkansas Resident Producer License, NPR No. 17830507 should be revoked.
