ORDER

The Arkansas Cemetery Board (“Board”) held its quarterly meeting on December 20, 2017, pursuant to Ark. Code Ann. § 20-17-1005 and Rule 5 of the Rules of the Arkansas Cemetery Board. Among the matters considered was a request by Pinewood Memorial Park, Inc. to ratify a proposed change in trustee of Pinewood Memorial Park from First National Bank of Crossett as bank trustee to a Lisa B. Jones, Richard Myhand, and Jennifer Walker as trustees. Upon consideration of the testimony of the witnesses, the exhibits, and all other matters presented, the Board hereby finds and concludes:

FINDINGS OF FACT

1. Pinewood Memorial Park is located in Crossett, Arkansas and is licensed by the Board as a perpetual care cemetery as defined by the Cemetery Act for Perpetually Maintained Cemeteries, Ark. Code Ann. §§ 20-17-1001—20-17-1030, (“Act”).
2. The cemetery is owned and controlled by Pinewood Memorial Park, Inc.
3. On August 23, 2016, Pinewood Memorial Park, Inc. filed a proposed permanent maintenance trust fund agreement with the Board. This permanent maintenance trust fund agreement would replace the cemetery’s current permanent maintenance trust fund agreement and would establish Lisa B. Jones, Richard Myhand, and Jennifer Walker as trustees.

4. Lisa B. Jones, Richard Myhand, and Jennifer Walker will comply with the requirements of a trustee as required in Ark. Code Ann. 20-17-1014(b)(2).

5. The proposed permanent maintenance trust fund agreement, which involves a change of trustee, meets all statutory requirements as set forth in Ark. Code Ann. § 20-17-1013(d)(1) and (2).

CONCLUSIONS OF LAW

5. A new permanent maintenance trust fund shall be executed in writing and approved by the Board. Ark. Code Ann. § 20-17-1013(d)(1) and (2).

ORDER

The permanent maintenance trust fund agreement proposed by Lisa B. Jones on behalf of Pinewood Memorial Park establishing Lisa B. Jones, Richard Myhand, and Jennifer Walker as trustees of the Pinewood Memorial Park permanent maintenance trust fund agreement is hereby approved.

IT IS SO ORDERED.
