Financial assets and liabilities are classified based upon the lowest level of input that is significant to the valuation. When quoted prices in active markets for identical assets and liabilities are available, we use these quoted market prices to determine the fair value of financial assets and liabilities and classify these assets and liabilities as Level 1. In other cases where a quoted market price for identical assets and liabilities in an active market is either not available or not observable, we estimate fair value using valuation methodologies based on available and observable market information or by using a matrix pricing model. These financial assets and liabilities would then be classified as Level 2. If quoted market prices are not available, we determine fair value using broker quotes or an internal analysis of each investment's financial performance and cash flow projections. Thus, financial assets and liabilities may be classified in Level 3 even though there may be some significant inputs that may be observable.

25. Change in incurred claims and claims adjustment expense

As of September 30, 2017, reserves for incurred claims and claim adjustment expenses attributable to insured events of prior years decreased by \$4,356,716 from \$6,775,857 in 2016 to \$2,419,141 in 2017. In 2016, reserves for incurred claims and claim adjustment expenses attributable to insured events of prior years' decreased by \$20,694,795 from \$43,712,522 in 2015 to \$23,017,727 in 2016. The lower than anticipated health care cost trend rates observed in 2017 and 2016 for claims incurred in 2016 and 2015, respectively, were due to moderating outpatient and physician trends and faster than expected claim payment speed. The Company considers historical trend rates together with knowledge of recent events that may impact current trends when developing estimates of current trend rates. Original estimates are increased or decreased as additional information becomes known regarding individual claims. Historical health care cost trend rates are not necessarily representative of current trends. The Company excluded the impact of the change in health care receivables related to pharmacy rebates from the above roll-forward to conform to NAIC Annual Statement presentation.

The methodology used in calculating the liability has been consistently applied between years. As of September 30, 2017 and December 31, 2016, accrued claim adjustment expenses were \$27,114 and \$75,781, respectively. The reserve is determined as a percentage of claims reserves. The Company periodically reassesses the percentage applied based on historical experience.






