The BENEFITS CHARGED OFF Exhibit is required to report any B.A. members (also referred to as "policyholders") who have died, where B.A. certificate proceeds are payable to the servicing funeral home, but did NOT get paid during the two (2) semi-annual periods following the period in which they incurred. If a Contract Funeral Home does NOT get benefits "rendered" or paid during the two (2) semi-annual reporting periods following the period in which they incurred, the benefits must be "charged off" against the B.A. records. The Contract Funeral Home is required to "absorb" the cost of the benefit owed to the Servicing Funeral Home.
