NOTES:

The BENEFITS PAID Exhibit is required to report any payments issued by the B.A. This includes any credits applied toward an itemized Statement of Funeral Goods and Services at the time of need. A benefit may be paid after it has been "rendered" during the period in which it was incurred or if it was a Benefit Owning from a prior reporting period (not more than two periods following the period in which it incurred).

IMPORTANT: A benefit should not be listed as being both **PAID and OWED** for the same B.A. member or individual with the same certificate number during the same reporting period. It should be reported as either a **BENEFIT PAID** or a **BENEFIT OWING** during a reporting period.
