**EMERGENCY SUSPENSION ORDER**

---

On this day, the matter of Kyle Evans (“Respondent”) came before Allen Kerr, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Gray Allen Turner, Associate Counsel, in this matter. From the facts and law before him, the Commissioner finds as follows:

**FINDINGS OF FACT**

Respondent holds an Arkansas Resident Insurance Producer License, National Producer Number 17526473, Respondent resides in Faulkner County.

1. On June 7, 2017, the Arkansas Insurance Department received a notice from State Farm that Respondent's appointment had been terminated for cause. Respondent submitted false insurance policy applications for at least four consumers, a violation of Ark. Code Ann. § 23-64-512(a)(8).
2. Respondent has failed to cooperate with the Department investigation, a violation of Ark. Code Ann. § 23-64-512(a)(17). Specifically, the Respondent, after being sent proper notice, failed to attend an investigative conference on December 6, 2017, and failed to respond to the conference notice.

## CONCLUSIONS OF LAW


From the Findings of Fact contained herein, the Commissioner concludes as follows:

1. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. § 23-61-103.
2. The Commissioner has the authority to issue an emergency license suspension pursuant to Ark. Code Ann. §§ 23-64-216(e) and 25-15-211(c).
3. An administrative hearing will be held promptly, as required by Ark. Code Ann. § 23-64-216(e)(2). A Notice of Hearing is being served herewith.
4. The Commissioner and the Department reserve the right to amend the allegations, findings and conclusions set forth herein and further reserve the right to present additional allegations and evidence in any subsequent order or administrative hearing.

### IT IS THEREFORE ORDERED:

In consideration of the Commissioner's Findings of Fact and Conclusions of Law, the Respondent's Arkansas Resident Insurance Producer License, National Producer Number 17526473, and all lines of authority are hereby immediately suspended.
