EMERGENCY SUSPENSION ORDER

---

On this day, the matter of Danielle Lamberth (“Respondent”) came before Allen Kerr, Arkansas Insurance Commissioner (“Commissioner”). The Arkansas Insurance Department (“Department”) is represented by Gray Allen Turner, Associate Counsel, in this matter. From the facts and law before him, the Commissioner finds as follows:

**FINDINGS OF FACT**

1. Respondent, a resident of Faulkner County, holds an Arkansas Resident Insurance Producer License issued May 8, 2017.
2. Respondent pled guilty to one count of Possession of a Controlled Substance, a class "D" felony, in Faulkner County Circuit Court on September 11, 2018.
3. Respondent failed to disclose her arrest of felony conviction to the Department, a violation of Ark. Code Ann. § 23-64-201.
4. The public health, safety, and welfare imperatively require emergency action.

**CONCLUSIONS OF LAW**

From the Findings of Fact contained herein, the Commissioner concludes as follows:

1. The Commissioner has jurisdiction over the parties and the subject matter pursuant to Ark. Code Ann. § 23-61-103.

2. The Commissioner has the authority to issue an emergency license suspension pursuant to Ark. Code Ann. §§ 23-64-216(e) and 25-15-211(c).

3. Respondent pled guilty to one count of Possession of a Controlled Substance, a class "D" felony, in Faulkner County Circuit Court on September 11, 2018. Respondent violated Ark. Code Ann § 23-64-512(a)(6), that authorizes a producer license to be suspended or revoked for being convicted of a felony.

4. An administrative hearing will be held promptly, as required by Ark. Code Ann. § 23-64-216(e)(2). A Notice of Hearing is being served herewith.

5. The Commissioner and the Department reserve the right to amend the allegations, findings and conclusions set forth herein and further reserve the right to present additional allegations and evidence in any subsequent order or administrative hearing.

IT IS THEREFORE ORDERED:

In consideration of the Commissioner's Findings of Fact and Conclusions of Law, the Respondent's Arkansas Resident Producer License, National Producer Number 17502348, is hereby immediately suspended.
