SUSPENSION ORDER

---

On this day, the matter of the producer's license of Matthew Pressley ("Respondent") came before Allen Kerr, Arkansas Insurance Commissioner ("Commissioner"). A hearing was held on July 2, 2019, in the First Floor Hearing Room of the Arkansas Insurance Department ("Department") pursuant to the Notice of Hearing dated May 1, 2019. The hearing was held before William Lacy, Compliance Manager with the Arkansas Insurance Department ("Hearing Officer") pursuant to his appointment by the Commissioner in accordance with Ark. Code Ann. § 23-61-103(e)(1). The Department was represented by Gray Allen Turner, Associate Counsel. The Respondent did not appear.

FINDINGS OF FACT

1. The Commissioner of Insurance has jurisdiction pursuant to the Arkansas Insurance Code, specifically Ark. Code Ann. §§ 23-60-101, *et seq.*
2. Respondent is a resident of Michigan.
3. Respondent holds an Arkansas non-resident producer license, NPN 18061168.
4. Respondent was sent notice of hearing on June 10, 2019, and an amended notice of hearing on June 27 by electronic, regular and certified mail to his last known address provided to the Department.

5. On March 23, 2019, Respondent was arrested for a felony. Respondent failed to notify the Department as to his arrest or criminal charge within thirty days.


### CONCLUSIONS OF LAW

1. Under the provisions of Ark. Code Ann. § 23-64-201, the failure to report to the Department a criminal charge within thirty days is grounds for suspension or revocation of a producer's license.

### RECOMMENDATION OF HEARING OFFICER

WHEREFORE, upon consideration of the evidence of record and the foregoing Findings of Fact and Conclusions of Law, the Hearing officer recommends the following:

1. That the Arkansas non-resident insurance producer license of the Respondent be suspended for a period of twelve months from the entry of this order.
