REVOCATION ORDER

---

On this day, the matter of the producer’s license of Terrance Thomas (“Respondent”) came before Alan McClain, Arkansas Insurance Commissioner (“Commissioner”). A hearing was held on November 20, 2019, in the First Floor Hearing Room of the Arkansas Insurance Department (“Department”) pursuant to the Notice of Hearing dated November 7, 2019. The hearing was held before Booth Rand, Associate Counsel with the Arkansas Insurance Department (“Hearing Officer”) pursuant to his appointment by the Commissioner in accordance with Ark. Code Ann. § 23-61-103(e)(1). The Department was represented by Gray Allen Turner, Associate Counsel. The Respondent did not appear.

FINDINGS OF FACT

1. Respondent is a resident of Pulaski County.
2. Respondent holds an Arkansas resident producer license, NPN 17807557.
3. On or about September 4, 2019, the Department received notice from the Arkansas Office of Child Support Enforcement that the Respondent is three (3) or more months in arrearage on his child support obligations.
4. The Respondent has failed to enter into an approved payment plan with the Office of Child Support Enforcement or pay his arrearages.

5. Respondent was sent notice of hearing on November 7, 2019, by regular and certified mail to his last known address provided to the Department.

### CONCLUSIONS OF LAW

From the Findings of Fact contained herein, the Commissioner concludes as follows:

1. The Commissioner of Insurance has jurisdiction pursuant to the Arkansas Insurance Code, specifically Ark. Code Ann. §§23-6-101 *et seq.*
2. Under the provisions of Ark. Code Ann. § 23-64-512(a)(14), the failure to comply with an order imposing a child support obligation is grounds for suspension or revocation of a producer's license.

### RECOMMENDATION OF HEARING OFFICER

WHEREFORE, upon consideration of the evidence of record and the foregoing Findings of Fact and Conclusions of Law, the Hearing officer recommends the following:

1. That the Arkansas resident insurance producer license of the Respondent be revoked.
2. That following the expiration of three (3) years from the date of this order, the Respondent may apply to reinstate his license in accordance with the provisions of Ark. Code Ann. § 23-64-217(b).
